International Stuttering Awareness Day

Imagine trying to order a hamburger while stumbling and hesitating over the first syllable. The waiter is waiting. Finally you give up and order a cheeseburger--- only because it's easier to say. For millions of people who stutter this is a shared experience -One of the many that can lead to a sense of futility and retreat from social activity.

Fifteen years ago, the National Stuttering Association (USA) received a letter from 12- year- old girl telling us she asked her doctor why she stuttered. "We forgot to cut the string under your tongue,' was his response.

The history of stuttering, as well as its causes and treatment, is worth examining because it tells us of long standing misconceptions to understand stuttering.

The Greek philosopher Demosthenes overcame his stuttering affliction by placing pebbles in his mouth.

Sir Frances Bacon thought stuttering could be cured by applying hot wine to the tongue.

In the first half of the 19th century, a Viennese doctor was convinced that the tongue of a person who stutters was too large. The doctor solved the problem by cutting away the excess with surgical tools. Later, razor sharp horse bits were inserted into the mouth and by 20th century, the person who stuttered became fair game for stuttering schools, monotone voice patterns, arm swinging and singing were purported 'cures'.

We have heard within the last 6 years of an African witchdoctor who helped a mother with a stuttering child. The child was diagnosed as being 'possessed by demons' and was killed.

The professional and consumer stuttering community are working together to increase awareness and focus attention on stuttering in an appropriate manner.

International Stuttering Awareness Day is an opportunity to change public attitudes and beliefs about stuttering, as well change personal perceptions that as People who Stutter we may have adopted.
